PRIVACY STATEMENT

Human Rights Council Of India will keep the user information collected through its website (www.hrcofindia.org) strictly confidential. It will not be shared with any external agencies or individuals. However, Human Rights Council Of India will keep the users updated about its happenings and developments through bulletins and newsletters with an option of not to subscribe the same.

While forwarding a donation for Human Rights Council Of India the well-wishers have to submit a few personal information as it would help us ensuring genuine contributions:

1. Your name
2. Your email and mailing address
3. Your telephone number
4. Your payment processing details
5. Any other data as Human Rights Council Of India may require

You will be asked to provide your personal information when making donations, making purchases at our on-line Gift Shop, requesting communications, applying for a job with Human Rights Council Of India and/or in connection with other Human Rights Council Of India business (whether it is via the website, e-mail, direct mail or telephone communications).

All relevant information collected through Human Rights Council Of India website is handled and used by internal and authorized officials only.

General browsing of Human Rights Council Of India website is anonymous and it does not register the user's personal information except the time, date and place of visits and the name of internet service provider. However, this information is not shared by the organization with external agencies.

Human Rights Council Of India is not liable for any form of loss, damage or harm caused to the users as a result of misuse of personal information by a third party, tracked through a linked site of Human Rights Council Of India or otherwise, and who is not an employee of Human Rights Council Of India holds the discretion to modify the terms and conditions under privacy policy.

Your personal information will also be used to provide you access to the various sections of our website that have been personalized for your needs. Human Rights Council Of India will never intentionally share your e-mail addresses, phone numbers or financial information.

SECTION 1 - WHAT DO WE DO WITH YOUR INFORMATION?

When you purchase something from our store, as part of the buying and selling process, we collect the personal information you give us such as your name, address and email address.

When you browse our store, we also automatically receive your computer's internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system.

How do you get my consent?

If we ask for your personal information for a secondary reason, like marketing, we will either ask you directly for your expressed consent, or provide you with an opportunity to say no.

How do I withdraw my consent?

We may disclose your personal information if we are required by law to do so or if you violate our Terms of Service.

SECTION 4 - PAYMENT

We use Razorpay for processing payments. We/Razorpay do not store your card data on their servers. The data is encrypted through the Payment Card Industry Data Security Standard (PCI-DSS) when processing payment. Your purchase transaction data is only used as long as is necessary to complete your purchase transaction. After that is complete, your purchase transaction information is not saved.

Our payment gateway adheres to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover.

PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.
